<p><b>Continuing validity of the declaration of conformity</b></p>					
<p>The issuer of the declaration of conformity shall have procedures in place to ensure the continued conformity of the medium risk article, as delivered or accepted, with the stated requirements of the declaration of conformity.</p> <p>The issuer of the declaration of conformity shall have procedures in place to re-evaluate the validity of the declaration of conformity, in the event of:-</p> <ol style="list-style-type: none"> <li>changes significantly affecting the article design or specification,</li> <li>changes to the standards which conformity of the article is stated,</li> <li>changes in the ownership or structure of management of the supplier,</li> <li>if relevant, or relevant information indicating that the article may no longer conform to the specified requirements.</li> </ol>

Penalties associated with a grade A offence are fines, not exceeding \$10,000 for an individual or \$50,000 for a body corporate (company) if successfully prosecuted, or a fixed infringement fee, of \$1,000 for an individual or \$3,000 for a body corporate (company).</p>
